**ORDINANCE NO. 2017-673
(Duly adopted December 4, 2017)**

**AN ORDINANCE RETAINING THE BOROUGH OF BATH REAL ESTATE TAX
RATE FOR THE FISCAL CALENDAR YEAR 2018 AT 15 MILLS.**

WHEREAS, pursuant to Section 1302 of the Borough Code (as reenacted April 18, 2014, P.L. 432, No. 37) authorizes Borough Council of the Borough of Bath (the “Borough”) to levy taxes on the valuation assessed by the County on real estate within the Borough; and

WHEREAS, Borough Council of the Borough of Bath is the body duly authorized to determine the tax rate necessary to generate sufficient revenues to support Borough expenditures; and

WHEREAS, as part of the Budget process, Borough Council of the Borough of Bath has determined that it is necessary to retain the tax rate at 15 mills for the upcoming 2018 fiscal and a calendar year in order to meet necessary Borough expenditures; and

NOW, THEREFORE, be it and it is hereby **ORDAINED** by the Borough Council of the Borough of Bath, that the tax millage rate for the Fiscal and Calendar Year 2018 shall be 15 mills. This rate shall continue from year-to-year unless affirmative action is taken by Borough Council to raise or lower the tax rate.

The tax rate remains 15 mills on each dollar of assessed valuation or 150 cents on each one hundred dollars of assessed valuation for the Fiscal and Calendar Year 2018 summarized in tabular form as follows:

| Fire Protection Tax | 0.250 mills | \$0.025 |
| TOTAL | 15.00 mills | \$1.500 |
