4. Please make special requests (ie. extra tables, benches, etc.) at the time of reservation.
5. Keys are to be picked up at the Borough Office the Friday immediately preceding the rental date.
6. Keys are to be returned to the Borough Office the Monday immediately after the rental date.
7. Cash deposit will be returned when the Borough Office receives the set of keys pending no damages are found during the inspection that is performed following your rental.

It is expressly agreed and understood that this WAIVER and RELEASE shall apply for the express purpose of precluding forever all claims, suits, demands, damages and cause of action that the undersigned, their heirs , next of kin, executors, administrators, estate, agents and assigns and representatives and/or third party of any nature whatsoever might otherwise assert against the Borough of Bath and all officers and employees thereof, as a result of participation in Rental and Usage of Borough of Bath Recreation Facilities and exposure to, contraction of and/or actual illness from the COVID-19 virus including but not limited to any physical, bodily or mental injury of whatsoever kind as a result of Releasor's participation in Rental and Usage of Borough of Bath Recreation Facilities.

Understanding, acknowledging, and agreeing to all of the risks involved, we hereby agree to expressly and voluntarily accept and assume all risks involved with the Rental and Usage of Borough of Bath Recreation Facilities including but not limited to all known or unknown risks, exposure to, contraction of and/or actual illness from the COVID-19 virus including bodily and/or mental injury of whatsoever kind as a result of my participation in Rental and Usage of Borough of Bath Recreation Facilities.
