*On December 1, OOR issued a partial grant of Reconsideration, denying attorney-client privileged issue—1 of 3 inseparable issues the Borough requested reconsideration.*

*Borough argues OOR doesn't have the authority to grant 'partial' reconsideration. OOR may either wholly grant or deny the request.*

*OOR, after asking the Borough about its jurisdiction to handle the matter, later denied Bath's position OOR lacked jurisdiction even though the Borough filed a petition of review with NCCCP.*

*OOR decided it would proceed with reconsidering its Final Determination of November 3, 2023.*
